RESULTS

- ➤ organization of the "Legal Information Day" project in schools, providing legal explanations to the population by qualified specialists (lawyers, notaries, legal services employees, etc.) on a specific day;
- ➤ expanding the coverage of topics aimed at preventing corruption and crime in the 8-11th grade textbook "Basics of State and Law", applying legal issues in all law textbooks and forming independent opinions of young students in such situations.
- ➤ explaining to the students that the activities related to the development of the social sphere are related to the essence of the state policy on youth in our country, and to regularly conduct radio broadcasts promoting legal culture in schools; (Thursday is "Legal Literacy" day.)
