In the context of prohibition speech acts, the illocutionary force is to establish a prohibition, i.e., to forbid certain actions or behaviors. This prohibition can be explicit, as in the case of direct commands ("Don't touch that!"), or implicit, as in indirect requests ("I would appreciate it if you didn't interrupt").

Linguistic Mechanisms of Prohibition Speech Acts:

In analyzing prohibition speech acts, it is essential to consider the linguistic mechanisms that enable speakers to convey prohibitions effectively. One key feature of prohibition speech acts is the use of imperative forms, which signal a directive or command. Imperatives, such as "Don't," "Stop," or "No," are frequently used to explicitly forbid certain actions.
