The most complete in modern domestic linguistics the theoretical and methodological foundations of Linguoculturology are set forth in Vorobev's work Linguoculturology: Theory and Methods. According to Vorobev, Linguoculturology is considered as the theoretical basis of linguistic culture; It is defined as "a complex scientific discipline of the synthesizing type that studies the interrelation and interaction of culture and language in its functioning and reflects this process as an integral structure of units in the unity of their linguistic and extralinguistic (cultural) content through systematic methods and with an orientation to modern priorities and cultural Establishment (a system of norms and universal values). The problem of correlation, interconnection, mutual influence of language and culture, a cultural phenomenon in the language, has a general scientific value in linguistics and, in fact, is interdisciplinary. Therefore Linguoculturology plays important role in modern research [1].

Linguoculturology is a humanitarian discipline that studies material and spiritual culture embodied in a living national language and manifested in linguistic processes. It allows you to establish and explain how one of the fundamental functions of language is carried out – to be an instrument for the creation, development, storage, and transmission of culture. Its goal is to study the ways in which language embodies in its units, stores and translates culture. According to Y.A. Belchikov, one of the topical problems of modern Linguoculturology is connected with the search for mechanisms of interaction between language and culture, because "language and culture have a common humanistic basis". The aim of Linguoculturology is to study the methods which the language embodies in its units, to keep and to transmit culture [2]. Linguoculturology studies the national forms of being of society reproducedin the system of language communication and based on the cultural values of a specific historical community. The most important task of Linguoculturology and its characteristic distinguishing feature is the systematic representation of the culture of the people in its language. Linguoculturology explores the linguistic picture of the world, gives a systematic description of the facts of language and culture in their interaction and interrelation. A.T Khrolenko explains this "The subject is the fundamental issues related to the transforming side of the connection between language and culture: changes in the language and its units, conditioned by the dynamics of culture, as well as changes in the structure and changes in the functioning of culture, predetermined by the language realization of cultural meanings" [3]

When we analyze the place of a concept in linguistics, we first focus on the word concept. Is it possible to use the terms "concept", which is a product of logical activity, and "concept", which are widely used in cognitive linguistics.

The dictionary of cognitive terms defines the term "concept" as follows: A concept is a concept that serves to reflect the mental and psychic resources of our thinking in human knowledge and skills. The term "concept" in modern linguistics is used to describe the image of a lexical unit in thought. is used. In everyday scientific work, the term concept is often used as a synonym for concept [6]. Origin: In the days before anesthesia, injured soldiers would bite on a bullet to endure the pain during surgery. - c) In the trenches. Meaning: Actively engaged in a difficult task or dealing with a challenging situation. Origin: This phrase comes from World War I, where soldiers fought from trenches dug in the ground. It conveys the idea of being immersed in a difficult task or situation.
- d) To go over the top. Meaning: To take extreme or excessive action.
- e) Origin: This idiom also comes from World War I. "Going over the top" meant leaving the safety of the trenches and charging into enemy territory, often resulting in heavy casualties.
- f) At loggerheads. Meaning: To be in strong disagreement or dispute. Origin: Loggerheads were iron tools with long handles used to heat liquids in ship galleys. Sailors would sometimes use them as weapons during fights, leading to the phrase being used to describe conflicts.
- g) To bury the hatchet. Meaning: To make peace with someone or to end a conflict. Origin: This expression comes from the Native American custom of burying a hatchet or tomahawk when peace was declared between tribes.
- h) To extend an olive branch. Meaning: To offer peace or reconciliation. Origin: In ancient Greece, the olive branch symbolized peace and victory. Offering an olive branch was a gesture of goodwill and the desire for peace.
- i) To give someone a piece of your mind. Meaning: To express one's anger or dissatisfaction with someone. Origin: Although this phrase may sound confrontational, it actually originates from a peaceful Quaker practice. In the 1600s, giving someone "a piece of your mind" meant sharing your thoughts and feelings calmly, hoping to resolve a conflict.
- j) To make one's peace with. Meaning: To accept a situation and come to terms with it. Origin: This phrase has religious roots, with the idea of making peace with God or oneself after a difficult or challenging period.
- k) A meeting of the minds. Meaning: An agreement or mutual understanding between people. Origin: This expression is derived from the Latin term "consensus ad idem," meaning "agreement to the same thing." It emphasizes the importance of understanding and harmony in resolving disputes.
- 1) To wage war on something. Meaning: To actively combat a problem or issue. Example: The government is waging war on drug trafficking to protect its citizens.
- m) To call a truce. Meaning: To agree to stop fighting or arguing for a period of time. Example: After hours of arguing, the siblings called a truce and decided to find a compromise.

- n) To hold out an olive branch. Meaning: To make a gesture of peace or reconciliation. Example: Sarah held out an olive branch by apologizing and inviting her friend to dinner.
- o) To keep the peace. Meaning: To maintain harmony or avoid conflict. Example: The mediator was brought in to keep the peace during the heated negotiations.
- p) To give peace a chance. Meaning: To explore peaceful alternatives before resorting to conflict. Example: The protesters urged world leaders to give peace a chance and reconsider their aggressive policies [11].
