

For instance, the same phrasal verb can have multiple meanings, depending on the context in which it is used, making it challenging for learners to grasp the correct interpretation.

A phrasal verb can have a literal meaning, i.e. pick up – to lift something up from a surface,

e.g. Be careful when you pick up the bag; it's heavy.

Or, it can have an idiomatic meaning, i.e. pick up – to learn a new skill or habit without intending to,

e.g. I just picked up a few words of Turkish when I was on holiday in Izmir.

Phrasal verbs should be seen as words (lexical items) in their own right and not simply as a combination of two or three words.

There are several challenges associated with phrasal verbs that can make them difficult for English language learners to master. The meaning is often impossible to guess from the individual words.

1. Multiple meanings: Phrasal verbs often have multiple meanings depending on the context in which they are used. This can lead to confusion and uncertainty for learners trying to understand and use them correctly.

"Take off":

- Meaning 1: to remove something, such as clothing or a hat ("Please take off your shoes before entering the house").

- Meaning 2: to become successful or popular suddenly, like a song or a product ("The new single by the band really took off and became a hit").

2. Idiomatic usage: Phrasal verbs are often used idiomatically, meaning that their meanings cannot be deduced from the individual words that make them up. This makes it challenging for learners to predict or understand the intended meaning of a phrasal verb in a given sentence.

"Blow off":

- Idiomatic meaning: to choose not to attend or participate in something, often without giving notice or a valid reason ("He blew off the meeting and didn't show up").

3. Separable vs. Inseparable: Some phrasal verbs can be separated by the object of the verb, while others cannot. Understanding when a phrasal verb is separable or inseparable can be a source of confusion for learners.

"Take out":

- Separable: Can you take the trash out, please?

- Inseparable: He took out his frustration on his coworkers.

4. Informal vs. Formal usage: Phrasal verbs are more commonly used in informal speech and writing, whereas their formal counterparts are often single-word verbs. This difference in formality can be challenging for learners to navigate in different contexts.

"Catch up" (informal):

- Informal: We should catch up over coffee sometime.

"Carry out":

- Formal: The committee will carry out a thorough investigation into the matter.

5. Lack of direct translations: Phrasal verbs often do not have direct equivalents in other languages, making them particularly challenging for learners whose native languages do not use similar constructions.

Moreover, the idiomatic nature of phrasal verbs adds another layer of complexity for learners. Idiomatic phrasal verbs often convey meanings that

cannot be inferred from the literal meanings of their constituent parts, requiring learners to have a deeper understanding of the language and its nuances to use them appropriately. This aspect of idiomatic usage can be particularly challenging for non-native speakers who may struggle to discern the intended meaning of phrasal verbs in different contexts.

Additionally, the distinction between separable and inseparable phrasal verbs presents a unique challenge for learners. Understanding whether a phrasal verb can be separated by its object or not can impact the structure and interpretation of sentences, further complicating the acquisition and usage of these linguistic elements.
