1. **wage theft**- the failure to pay salaries or benefits to an employee as required by a contract or the law is known as wage theft. Employers can do this in a number of ways, such as by failing to pay overtime, by breaking the minimum wage law, by misclassifying their workers as independent contractors, by illegally withholding wages, by making them work "overtime," by failing to pay for annual leave or vacation time, or by simply not paying them at all.
2. **Ponzi schemes**- is a type of financial scam in which money from new investors is used to pay alleged returns to previous investors. Ponzi scheme operators frequently entice new investors by offering to put money in possibilities that will allegedly provide great returns with no risk. Ponzi schemes need ongoing funding from new investors since they provide little to no genuine income. Ponzi schemes invariably fail, most frequently when attracting new investors becomes challenging or when a sizable proportion of investors request their money back
3. **Fraud**- is a deliberate deception intended to give the offender an unauthorized benefit or to revoke a victim's rights. Tax fraud, credit card fraud, wire fraud, securities fraud, and bankruptcy fraud are all examples of fraud. Fraudulent conduct can be committed by a single person, a group of people, or an entire company.

4. **Bribery**-When someone offers, provides, receives, or accepts something of value in exchange for the ability to influence or control the behaviour of another person, they are committing the crime of bribery. The actual bribe is the gift of cash or other assets made with the expectation that the recipient will behave differently than he would under normal circumstances.
5. **Racketeering**-When someone engages in racketeering, they put up a coercive, dishonest, extortionate, or otherwise criminal coordinated strategy or operation (a "racket") in order to regularly or continuously earn a profit.
6. **Cybercrime**-A crime involving a computer or computer network is referred to as cybercrime. The computer might have been the intended victim or it could have been utilized in the crime. Security or financial loss might result from cybercrime.

There are many types of white-collar crime in society. I think that if we count each of them, I would write hundreds of articles.

Now let's talk about some types of blue-collar crime.

Types of blue-collar crime:

1. **Shoplifting**-It entails robbing a store of its merchandise while acting like an ordinary consumer.
